ASX:TTM



Titan Minerals (ASX:TTM) is an emerging gold developer and copper explorer, focussed on discovering and developing Tier One deposits in Ecuador. The Company has significant exposure to large-scale copper and gold through its projects in Ecuador's southern Andean copper belt. The Dynasty Gold Project hosts Mineral Resources of 3.1 Moz gold and 22 Moz silver, which is set to grow with recent exploration work confirming extensive mineralisation outside currently defined resources in the 9km epithermal gold corridor. Dynasty boasts multiple compelling exploration and resource extensional targets in areas never previously explored. A ~10,00m drilling campaign is underway at Dynasty and set to deliver substantial resource growth, with a resource update targeted for mid-2025. A JV & Earn-in agreement was recently executed with Hancock subsidiary Hanrine, whereby Hanrine can earn an 80% interest in the Linderos Copper Project by spending up to \$180M. Commencement of a fully funded 10,000m drilling campaign to test the copper porphyry potential at the Linderos Project is imminent, with a steady flow of drill results to be delivered in the coming months.

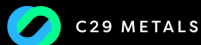
Ora Gold (ASX:OAU) holds a substantial package of tenements in the prolific Murchison goldfield near Meekatharra, Western Australia, with a focus on the Garden Gully Gold Project, comprising approximately 677km² in the Abbotts Greenstone Belt and other key regional structures, with the most advanced being the Crown Prince Prospect. The Company recently entered a binding agreement with Westgold Resources (ASX:WGX), forming a strategic alliance to advance Crown Prince to production, coupled with a \$6 million placement. Ora has also achieved highly encouraging metallurgical teamwork results with overall gold recoveries ranging from 98.2% - 99.8%.

Cleo Diagnostics (ASX:COV) is bringing to market a simple blood test for the accurate and early diagnosis of ovarian cancer which is the most deadly of all cancers that affect women. A significant global total addressable cancer diagnostics market exists. The technology is supported by gold-standard clinical evidence, underpinned by novel patented CXCL10 biomarker. Cleo is advancing the availability of its simple blood test, under a modular execution strategy to ultimately address all ovarian cancer detection markets with specific tests including surgical triage, recurrence, high risk, and early-stage screening. An FDA-enabling clinical trial is currently underway, with the aim of entering the first pre-surgical diagnostic market in the U.S. next year.

Jade Gas Holdings (ASX:JGH) is a gas exploration company focused on achieving a cleaner and independent energy supply for Mongolia by developing multiple gas assets located in the South Gobi region. The project is being developed in partnership with the Mongolian government to deliver the country's first domestic gas supply and is ultimately designed to support Mongolia's aim to decarbonize the economy by improving the energy mix with cleaner fuel sources, deliver on its climate change commitments, and improve environmental and health benefits for its people. The Company has a substantial maiden contingent gas Resource of 246 Bcf and is currently focused on transitioning to initial gas operations.
